DEED OF DECLARATION OF TRUST

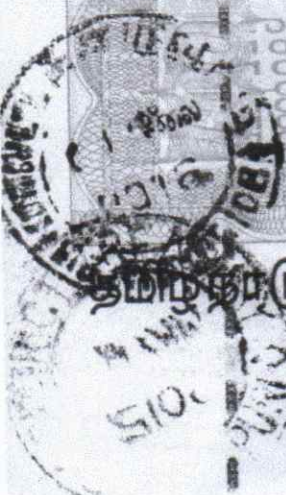

The benefits of the trust shall enure to the general public irrespective of caste, creed, sex or religion.

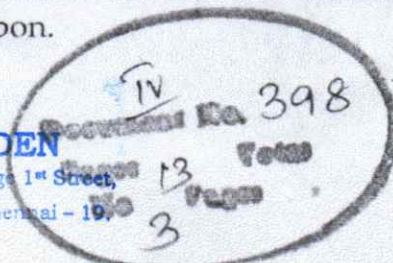
3) REGISTERED OFFICE OF THE TRUST:

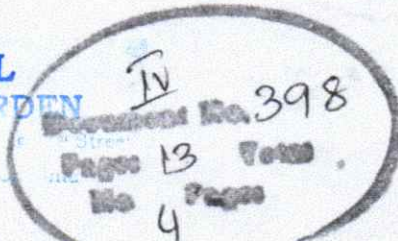

5) OBJECTS.

The objects of the Trust are and shall be:-

(a) EDUCATION

1. To establish, Promote, run, maintain, take over or assist financially or help in running schools including play schools and for coaching, guidance, counseling or vocational training or to grant individual scholarships for poor, deserving and needy students for elementary and higher education.
2. To give financial or other assistance in kind by way of distribution of books, notebooks, cloths, uniforms, or meals for the poor and indigent and to the persons who suffer due to natural calamities.
3. To grant, pay or give scholarship, stipends, prizes, rewards and other financial assistance help in cash or kind to students with a view to help them in pursuing their studies in schools, colleges, educational institutions, technical institutions to carry out research or educational works in India.
4. To publish and in publishing books, pamphlets and periodicals in India for the spread and advancement of education and culture.
5. To build, Construct, establish, take-over, run. Maintain, manage and/ or render financial help to any educational and /or scientific institutions for imparting education in all faculties.
6. To construct, establish, run, maintain, manage or render financial help to one or more institutes, Research institutions or other centers for the training of young men and women in Academic, technical, mechanical, scientific and similar pursuits.
7. To render financial help to any charitable organizations, institutions for poor and disabled persons requiring and deserving such help.

(b) MEDICAL RELIEF

To open, establish, run, maintain or assist any medical institution, nursing home or charitable dispensaries, child welfare centres, hostels etc., and to grant assistance to needy and indigent persons for meeting the cost of medical treatment.

(c) ANY OTHER OBJECT OF PUBLIC UTILITY

1. To acquire property for the sole use for public good by making it available for public purposes as for example, housing a library clinic, crèche and/or as a community hall to be available for public use as training classes, seminars, discourses and other public functions for benefit of the community in general.
2. To grant donations to any Public Charitable Institution.
3. To help the cause of any other object of general public utility.

(d) TO ACCEPT DONATIONS FROM PERSONS DESIROUS OF MAKING CONTRIBUTION FOR CARRYING OUT THE OBJECTS OF THE TRUST.

The above objects are mutually exclusive and the Trustees shall have absolute power to spend the income of the Trust on any of the objects at their discretion.

The surplus, if any, after meeting the expenses, can be accumulated and added on to the Corpus of the TRUST at the end of each year at the discretion of the Trustees.

The trustees hereby declare that not more than 5% of the income of the Trust would be applied to any religious purposes or given to religious institutions.

6) THE PROPERTIES OF THE TRUST

The properties of the Trust shall be.-

- (a) the said sum of Rs 5000/- above referred to the receipt of which is hereby acknowledged by the Trustees;
- (b) any properties movable or immovable, that may be acquired by the Trust either by purchase or otherwise;
- (c) all additions and acceptations to the Trust fund;
- (d) all voluntary donations both towards corpus or otherwise gifts, legacies or grants in cash or in kind accepted by the trustees;
- (e) all grants and contributions made to the Trust by the Government, Government bodies, Trust or Institutions, Trade Union or Societies etc; and

(f) all sums and assets which by and means become the property of the Trust.

At present, **GURU KRUPHA CHARITABLE TRUST** has no other Movable and Immovable properties except the **CORPUS FUND**.

- 7) The Trustees shall and will stand possessed of the investment of **Rs. 5000 (Rupees Five Thousand only)** for the time being representing the same (hereinafter referred to as "TRUST FUND") and also the net income of the Trust Fund into TRUST and other properties whether movable or immovable without any 'encumbrance' which the Trustees, may, from time to time, receive as donations towards the Corpus, bequests or from any other sources whatsoever for augmenting the funds of the Trust for the purposes connected with the objects of the Trust.

Any receipt with specific direction to treat the same as part of the Corpus of the Trust or separate fund shall be funded accordingly.

- 8) The trustees shall invest the TRUST FUNDS in Government Securities, fixed deposits in Nationalised Banks, Public Sector Companies or in any other manner so, however, that such investments shall always be made and remain as invested only in the manner as prescribed in the Income tax Act, 1961. Such investments shall be in the name of the Trust.

- 9) The trustees shall have the following powers:-

To sell, alter, vary, transpose or otherwise dispose or alienate the trust properties or any investment representing the same for consideration and to re-invest the same.



To pledge or mortgage the Trust properties for raising loans.

To file suit on behalf of the Trust and to refer to arbitration all actions, proceedings and disputes relating to Trust properties and to compromise and compound the suits filed.

To accept any gift, donation or contribution in cash from any one to carry out the objects of the Trust.

- 10) The Trust shall be managed by a Board of Trustees consisting of the **FOUR TRUSTEES**. The number of Trustees shall not be more than **SEVEN**. In case of any difference of opinion between the trustees, the opinion of the majority will prevail.

All the trustees will hold office for their lives unless they resign on their own accord or are removed in accordance with the regulations of the **TRUST**.

- 11) Any vacancy caused by death, resignation or removal of the Trustee or a trustee becoming incapable or unfit to act, shall be filled up by the existing trustees by appointing a suitable person of their choice.


- 12) The Managing Trustee, J.SenthilSwamy along with another trustee shall open account or accounts with such Bank or Banks as may be convenient, and the said account or accounts shall be operated by any two of the Trustees, jointly on behalf of the Trust.


- 13) The Managing Trustee shall maintain regular books of accounts for the moneys, properties and income and expenditure of the **TRUST**.

- 14) The Official Year of the trust shall be from 1st April of each year to the 31st March of the succeeding year. The first official year shall commence from the date of the original deed of Trust i.e., 29th August 2016 till the 31st day of March 2017. The accounts shall be audited by a qualified Chartered Accountant or a firm of Chartered Accountants and shall be placed before the Board of Trustees for its consideration and approval within three months from the end of the official year.

- 15) The Author of the Trust hereby declares that this is an irrevocable **TRUST**.

15. The Trustees may amalgamate the Trust with another Charitable Trust or Institution having similar objects and enjoying exemption under section 11 and 80-G of the Incometax Act, 1961 subject to the approval of the Director of Income Tax (Exemptions)

16) In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall, under no circumstances be distributed amongst the Trustees.

17) The Trustees shall at all times stand indemnified in respect of any act that may have been done bona-fide by them in respect of all matters relating to the Trust.

18) The Managing Trustee shall have power to file, contest or defend any civil or criminal proceedings or litigations in any Court or other Statutory Body on behalf of the TRUST.

19) The Trustees shall invest the TRUST FUND and the income there from, vary the investments from time to time and/or sell or realise the investments.

20) The Trustees shall have power from time to time to make or alter or amend the Rules and Regulations in regard to the conduct of the affairs of the Trust not inconsistent with the objects of the Trust

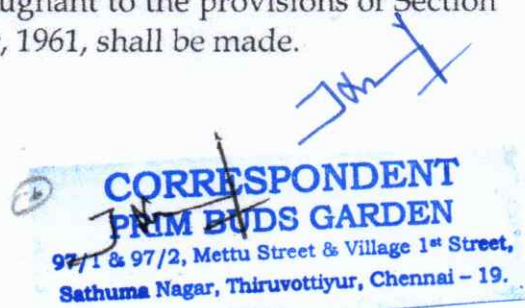
21) The Trust Fund including the Corpus of the Trust handed over and of the accumulations and receipts of the Trust shall be held only in the name of the Trust and not in the individual name or names of the Trustees.

22) Any alienation of immovables property belonging to the Trust shall be done only with the prior approval of the Director of Income Tax (Exemptions)

23) The funds and income of the Trust shall be utilised solely towards the objects of the Trust and no portion of the same shall be utilised for payment to Trustees or their close relatives as defined in Section 13 (1) (c) of the Incometax Act, 1961, by way of profit, dividend or interest whether directly or indirectly.


24) No activities of the Trust shall be carried on outside India and the activities shall not be carried on with the intention of earning any profit.

25) Any amendment, alternation or addition to this TRUST DEED can be carried out only with the approval of the Director of Income Tax (Exemptions). The Trustees shall not amend the Trust Deed as to affect the basic character of the Trust and no such amendments which prove to be repugnant to the provisions of Section 2 (15), 11, 12 & 13 and 80-G of the Income tax Act, 1961, shall be made.



26) If the objects for which the TRUST has been formed shall fail and cannot be fulfilled, the Trustees shall be at liberty to apply the Trust Fund to other Trusts or Institutions having similar objects and enjoying exemption under Section 11 and 80-G of the Income tax Act, 1961 subject to the approval of the Director of Income tax (Exemptions)


